4.	Resident will be responsible and will pay for any and all damages or destruction caused by the pet to the leased premises, appurtenances, any furnishings or other property of the Landlord, apartment building and surrounding areas. It is the responsibility of the Resident to include the repair of damaged items to their former condition and/or replacement where necessary, in the sole opinion of Landlord. This also includes treatment of fleas or ticks. It is recommended to treat your pet with a pest control substance regularly.	
5.	Resident agrees to put the pet out for board or otherwise remove the pet from leased premises for the balance of lease term if the pet is or becomes a nuisance or annoyance or interferes with the rights or enjoyment of other residents, or because of any noise or smells emanating from the pet, or damage by the pet, or if Landlord subsequently revokes this consent.	
6.	If requested, Resident will furnish Landlord with a copy of a comprehensive personal liability policy covering any loss or injury to Landlord and to any other residents, visitors, invitees or employees in the apartment building or other areas.	
7.	Resident acknowledges and agrees that Landlord may revoke this consent and/or amend and change Landlord's rules and regulations including any pertaining to pets without prior notice to Resident at any time, and Resident shall abide by such amendments or changes.
